This letter is in response to your Freedom of Information Act (FOIA) request for information concerning Special Agent Darcia A. Smith. Your letter was received in the Baltimore Disclosure office on March 23, 2007 and referred to the Detroit Disclosure office for response.

To the extent Darci A. Smith is a Special Agent, GS-1811, such agent's identity and appointment affidavit is exempt for disclosure pursuant to FOIA exemption (b)(6)

Section 701 of Title 18 of the U S Code states whoever manufactures, sells, or possesses any badge, identification card, or other insignia, of the design prescribed by the head of any department or agency of the United Sates for use by any officer or employee thereof, or any colorable imitation thereof, or photographs, prints, or in any other manner makes or executes any engraving, photograph, print, or impression in the likeness of any such badge, identification card, or other insignia, or any colorable imitation thereof, except as authorized under regulations made pursuant to law, shall be fined under this title or imprisoned not more than six moths, or both. We are unable pursuant to this section of the United States Code to provide a copy of the identification card of any Internal Revenue Service employee; these cards would be available for visual inspection at any meeting.

Exemption (b) (6) protects personnel and medical files and similar files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. This exemption relates to records that contain details about the private lives of individuals.



- 7. All records, if any, of <u>determinations</u> or <u>decisions</u> made that I am an individual who is, or was, required to pay a tax, keep records and/or submit forms to the national government of the United States of America or to the Internal Revenue Service;
- 8. All records, if any, of <u>determinations</u> or <u>decisions</u> made that I am an "individual taxable" under the revenue laws of the national government of the United States of America;
- 9. All records, if any, of determinations or decisions made that I am a "tax protester";
- 10. The <u>documents</u> that reflect the name. title, business address, bond number and delegation of authority to make such determinations or decisions of each and every person who made the determinations or decisions referred to in items numbered 2 through 9 above;
- 11. The <u>documents</u> that reflect the name, title, business address, bond number and delegation of authority to make such determinations or decisions of each and every supervisor of the persons referred to in item number 10 above;
- 12. The specific <u>documents</u> of <u>fact</u> relied upon in the making of all the above itemized determinations or decisions referred to in items numbered 2 through 9 above. which shall include, but shall not be limited to, any contracts or waivers of rights submitted by me;
- 13. The specific <u>documents</u> of fact relied upon to support any determination or allegation that I am protesting a tax and which would reflect whether I am allegedly protesting a **capitation** tax. a property tax or a tax on a revenue taxable activity;
